










What excites teachers about merger?








What concerns teachers about merger?

Integration

- How does a merger align with WLA's strategy?
- What gaps in our current strategic plan are accelerated / complemented / etc. with the contemplated merger?
- What core assumptions need to be true for a merger to make sense?

- Confirm fit / strategic rationale assumptions
- Identify operational efficiencies
- Begin high level integration planning
- Select integration leaders
- Administrator Meetings

- Merger structure defined and agreement drafted
- Plan of Merger (MDE requirement)
- Plan of Merger Approval (MDE requirement)
- Articles of Merger

Public Board Fiduciary Duties

- In the context of a significant decision such as a merger, it is important to review the standards that charter board members are held to
- Fiduciary duties are the highest standard duty implied by law and include the following:
 - <u>Duty of Care or Diligence</u> to act with the care a reasonably prudent person would use under similar circumstances and to act in good faith, which implies making decisions that are financially, ethically, and legally sound. A director must obtain and review relevant information, raise any matters of concern, and cause action to be taken to resolve any problems that are identified. These decisions should be made after taking all available information into account and carried out in a matter that is in the best interest of the school.
 - <u>Duty of Loyalty</u> the board member has a sole purpose to act in the best interest of the board and organization, to avoid conflict of interest, and act as a fiduciary.
 - <u>Duty of Obedience</u> to act in compliance with laws, regulations, charter bylaws, contracts, and board policies. A director must be familiar with these sources and remain informed of the organization's activities to assure management is adhering to the same. Furthermore, the director should make sure that all of the decisions being made are done in line with the mission or goals of the organization.
 - <u>Duty of Oversight</u> to be proactive in ensuring you have full and necessary information particularly in voting matters.

Simply put, fiduciary responsibility is to do what is right for the organization



Administration/Board Process



- WLA and MSA administrators will meet together frequently during the diligence period.
- WLA and MSA administrators will work independently with their own schools.
- Board members should be mindful of conflicts of interest and must adhere to their fiduciary duties.
- The role of WLA and MSA Merger Committees is to work in tandem to address questions and concerns from their respective communities. They will share out information with their school administrators.
