### **Agenda Item 2: Non-Negotiables**

#### Authorizers

- Pat: Doesn't know enough about authorizers to have a strong opinion.
- Ben: WLA authorized by volunteers of America, MSA is not. MSA smaller entity, run by someone nearing retirement age. WLA has a strong standing with our authorizer, and Ben's preference to stay with WLAs authorizer
- Ben: Different opinions from MSA on who to go with for the authorizer.
- Pat: agrees with Ben

#### **Facilities**

- Bailey: Wants to keep the facilities we currently have.
- Kathy: Not enough parking for our kids
- Tammi: k-8 stay at WLA since we put so much work to create the facilities we have. Safety at MSA is questionable since there are multiple buildings.
- Pat: Keep our facilities and try to make k-12 all at the WLA site
- Autumn: Also wants to keep facilities at WLA
- Ariel: MSA not a great campus for any ages including for high school

#### Curriculum

- Ariel: Likes WLA curriculum
- Tammi: Also likes WLA curriculum
- Pat: Also likes WLA curriculum
- Autumn: Middle school CK curriculum is not developed and it would be a great benefit to have additional curriculum resources. Perhaps k-5 can remain core knowledge, whereas middle school expands curriculum

• Bailey: CK curriculum is incomplete and what is offered is not meeting student needs. If we do not merge, we need to consider developing a better curriculum.
